

## **TERMS AND CONDITIONS – Al Basti Equiworld Dubai-sponsored Trip for 2 to the Dubai World Cup (Christchurch)**

1. The Competition opens at 11am on Saturday November 9 2019 and closes 1hr prior to the running of the G1 Al Basti Equiworld Dubai NZ 2000 Guineas on Saturday November 9 2019 (the **Competition Period**). All race book entry forms for the Al Basti Equiworld Trip for 2 to the Dubai World Cup that are completed and placed in the marked entry buckets on course will be entered in the draw so long as they are completed as set out in paragraph 2.
2. To be eligible to enter this Competition you must fully complete the Competition entry form in the race book. You must also be present on course on Saturday November 9 2019 to claim the prize. Entries are limited to one entry per person.
